## ESTATUTO DO INSTITUTO LIVRE MERCADO

### CAPÍTULO I - DOS ELEMENTOS DE CONSTITUIÇÃO DO INSTITUTO

#### Seção I – Denominação, Sede e Objeto

**Art 1º** O Instituto Livre Mercado, regido pelo presente Estatuto é uma entidade civil de direito privado, constituída nos termos dos artigos 53 a 61 do Código Civil, sem fins lucrativos, de natureza política apartidária, sediado no endereço SAUS Quadra 01 – Lote 02 – Bloco N – Sala 705 – Ed. Terra Brasilis em Brasília/DF, CEP: 70.070-010.

**Art 2º** O Instituto Livre Mercado tem como objetivo debater e contribuir para a melhoria das proposições legislativas defendendo sempre a liberdade, a responsabilidade individual, a iniciativa privada, o livre mercado, o direito de propriedade e o princípio da subsidiariedade.

**Art 3º** Para atingir seu objetivo o Instituto Livre Mercado buscará:

- 3.1 Promover o aperfeiçoamento, a desburocratização e a simplificação da legislação que incida sobre a liberdade de mercado
- 3.2 Colaborar, auxiliar e participar do desenvolvimento de políticas públicas que impactem a iniciativa privada, o livre mercado e a liberdade do consumidor
- 3.3 Cooperar, colaborar e assistir entidades públicas e privadas na promoção das finalidades do Instituto Livre Mercado
- 3.4 Contribuir no combate à adoção de práticas antiéticas que possam criar reservas ou desequilíbrio nas relações de mercado
- 3.5 Apoiar e dar suporte a ações de privatização, desestatização e transferência de funções do Estado à iniciativa privada

**Art 4º** São atividades do Instituto Livre Mercado:

- 4.1 Elaborar pareceres, orientações e opiniões técnicas para auxiliar no desenvolvimento e tramitação de propostas legislativas
- 4.2 Estabelecer termos de cooperação técnica com órgãos e estruturas do Poder Público, tais como Frentes Parlamentares, de maneira a auxiliar na execução de suas atividades e desenvolvimento de políticas

6.4 O Conselho de Administração deliberará e estipulará os respectivos valores para os membros apoiadores e mantenedores

- 19.3 Por qualquer outro integrante do Conselho de Administração

**Art 20º** O quórum mínimo para instalação da Assembleia Geral em primeira chamada é de cinquenta por cento dos votos totais existentes.

- 20.2 A segunda chamada deve ocorrer a partir de trinta minutos após o horário originalmente marcado que poderá ser instalada com qualquer quórum de votantes



24.2 Convocar as reuniões da Assembleia Geral e garantir a execução de suas deliberações

24.3 Contratar e demitir os integrantes da Diretoria Executiva e fixar-lhes as atribuições observando o que a respeito dispuser o estatuto

24.4 Fiscalizar a gestão dos diretores, examinar, a qualquer tempo, os livros e papéis do Instituto, solicitar informações sobre contratos celebrados ou em via de celebração e quaisquer outros atos

24.5 Manifestar sobre os balanços financeiros, relatórios gerenciais e de atividades elaborados pela Diretoria Executiva e encaminhar à Assembleia Geral para deliberação

24.6 Contratar e destituir, em conjunto com a Diretoria Executiva e o Conselho Fiscal, auditoria independente

24.7 Desenvolver o programa e diretrizes da Função *Compliance* do Instituto

24.8 Excluir associados, nos termos deste Estatuto

**Art 25º** O Presidente do Conselho de Administração e o Diretor Executivo representarão o Instituto em juízo ou fora dele, perante os poderes públicos e instituições financeiras, podendo para esse fim constituir procuradores, mandatários ou prepostos.

**Art 26º** O Conselho de Administração poderá instituir Comissões e outros órgãos administrativos ou auxiliares, os quais terão regimentos internos próprios previamente aprovados.

### Seção IV - Do Conselho Fiscal

**Art 27º** O Conselho Fiscal é o órgão de fiscalização financeira do Instituto e será composto por três membros titulares sem hierarquia entre si.

27.1 Cada membro terá o seu suplente específico que o substituirá em caso de necessidade

27.2 O mandato de cada membro do Conselho do Fiscal será de dois anos sendo permitida a reeleição

**Art 28º** Compete ao Conselho Fiscal:

28.1 Fiscalizar, por qualquer de seus membros, os atos dos administradores e verificar o

cumprimento dos seus deveres legais e estatutários

28.2 Opinar sobre o relatório anual da administração fazendo constar do seu parecer as informações complementares que julgar necessárias ou úteis à deliberação da Assembleia Geral

28.3 Emitir parecer sobre as contas apresentadas pela Diretoria Executiva semestralmente

28.4 Contratar e destituir, em conjunto com a Diretoria Executiva e o Conselho de Administração, auditoria independente

28.5 Opinar, sempre que solicitado, sobre as propostas dos órgãos da administração relacionadas às suas atribuições

28.6 Denunciar, por qualquer de seus membros, aos órgãos de administração e, se estes não tomarem as providências necessárias para a proteção dos interesses do Instituto, à Assembleia Geral, os erros, fraudes ou crimes que vierem a tomar conhecimento

28.7 Convocar a Assembléia Geral sempre que ocorrerem motivos graves ou urgentes

**Art 29º** Poderão candidatar-se ao Conselho Fiscal todos os que compõem o quadro associativo do Instituto, inclusive apoiadores e seus representantes.

### Seção V – Da Câmara de Mantenedores

**Art 30º** A Câmara de Mantenedores atuará como órgão de deliberação auxiliar, tendo participação na criação de metas e diretrizes para alocação dos recursos provenientes dos seus integrantes, além de possuir poder de voz sobre as deliberações e posicionamentos do Instituto.

## Seção VI – Da Diretoria Executiva

**Art 31º** A Administração do Instituto será feita por sua Diretoria e supervisionada pelo Conselho de Administração, o que inclui a gestão dos recursos, a representação do Instituto, o cumprimento das exigências legais, a promoção de seus fins e a execução de todas as demais atribuições previstas neste Estatuto.

**Art 32º** Compete à Diretoria Executiva:

- 32.1 Administrar, gerir e coordenar os trabalhos, programas e projetos do Instituto
- 32.2 Desenvolver ações relativas à gestão orçamentária e financeira aprovadas pelo Conselho de Administração
- 32.3 Propor políticas e planos estratégicos ao Conselho de Administração
- 32.4 Designar os responsáveis pelas funções gerencial e administrativa e realizar contratações e demissões de pessoal, desde que previamente aprovadas pelo Conselho de Administração
- 32.5 Fornecer todas as informações solicitadas pelo Conselho de Administração e Assembleia Geral, a qualquer tempo, ou que forem pertinentes ao acompanhamento das atividades do Instituto, inclusive a apresentação de relatórios na periodicidade definida pelo Conselho de Administração
- 32.6 Exercer todas as atribuições definidas pelo Conselho de Administração

**Art 33º** Os membros da Diretoria Executiva terão mandato de dois anos durante os quais todos os seus membros estão investidos dos poderes e incumbidos dos deveres previstos neste Estatuto.

**Art 34º** A Diretoria deverá ser composta por, no mínimo, dois diretores e, no máximo, quatro, entre os quais um será denominado de Diretor Executivo.

## CAPÍTULO III - DO PROCESSO ELEITORAL

**Art 35º** A cada dois anos, nos 3 (três) primeiros meses seguintes ao término do exercício social, deverá haver 1 (uma) Assembleia Geral para eleger os administradores e os membros do conselho fiscal.

## CAPÍTULO IV - DA GESTÃO FINANCEIRA, MATERIAL E DE INFORMAÇÃO

### Seção I - Dos Recursos Financeiros

**Art 36 °** O financiamento do Instituto e de suas atividades se dará pelas seguintes formas:
